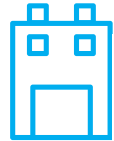

## Our State's Early Childhood Educators Need Support and Compensation

**14,500** Number of educators working with children birth through 5 <sup>(1)</sup>



**62%** percentage of educators indicating they are more burned out than they were in previous year <sup>(5)</sup>

 Scholarships to support early childhood educators in accessing professional development, and earning credentials and degrees <sup>(6)</sup>

## Federal Investments Support Access to Child Care and Early Learning and Increase the Well-Being of Children, Families, and Educators in Our State

**12,500** Number of children receiving child care assistance per month, on average <sup>(1)</sup>

**13%** Percentage of eligible children receiving child care assistance per month, on average <sup>(2)</sup>

**28,300** Average number of children accessing CACFP for nutrition while they attend early learning programs <sup>(3)</sup>

**12,698** Number of children accessing special education services through IDEA Preschool Special Education (part B 619) <sup>(4)</sup> and Early Intervention (part C) <sup>(5)</sup>

Programs including CCDBG, Head Start, IDEA, CCAMPIS, CACFP, CHIP, TANF, SNAP, MIECHV, and Medicaid, as well as tax credits such as the Child Care and Dependent Tax Credit and the Child Tax Credit, provide critical investments to support the well-being of young children, their families, and the early childhood educators who support them.
