Recognition Application Fee	Registered programs may apply for Recognition. Once the fee is submitted, your documentation will undergo review and scoring, and if approved, the program will be awarded 'Recognized' status for a 1-year term. Accreditation Application Fee	Recognized programs may apply for Accreditation. Once the fee is submitted, your documentation will undergo review and scoring, and if approved, the program will be awarded 'Accreditation' status for a 5-year term. Accreditation+ Site Visit Fee	Accredited programs may request an Accreditation+ Site Visit to upgrade to Accredited+ status. To receive a site visit and upgrade your Accredited status to Accreditation+ programs must pay an Accreditation+ Site Visit Fee. Accreditation Annual Fee	Accredited programs are required to submit yearly annual reports & fees to maintain their NAEYC Accreditation for the five-year term. The first annual report and fee is due one year after Accreditation is awarded and is due every year after that as long as the program wishes to remain accredited, submits renewal documentation, and meets all Accreditation requirements.	\$650	\$750	\$900	\$1,025	\$1,200	\$1,375	\$1,550
Accreditation+ Annual Fee	Accredited programs are required to submit yearly annual reports & fees to maintain their NAEYC Accreditation+ status for the five-year term. Accreditation Renewal Application Fee	For programs wishing to renew into the Accreditation tier, renewal application review is included in the cost of the Annual Fee. Programs must submit renewal documentation, but there is no additional fee required. Accreditation+ Renewal Application Fee	For program wishing to renew into the Accreditation+ tier, renewal application review is included in the cost of the Annual Fee. Accreditation+ Site Visit Fee	For programs wishing to renew into the Accredited+ tier AND who have already passed the documentation review, programs must pay the Accreditation+ Site Visit Fee. <i>Extension Fee</i>	To extend the accreditation term, programs must pay the extension fee PLUS the prorated amount of the annual fee for the duration of the extension.
